A PARKING CHARGE OF £80.00 WILL BE PAYABLE IF YOU DO NOT ABIDE BY THE TERMS AND CONDITIONS. SEE MAIN BOARDS IN CAR PARKS AT ALL CAMPUSES FOR FULL DETAILS

BY ENTERING, WAITING AND REMAINING ON THE CAR PARK OR PARKING RESTRICTED AREA, THE DRIVER ENTERS A CONTRACT WITH US TO COMPLY WITH THE TERMS AND CONDITIONS OF THE AREA AND TO PAY ANY PARKING CHARGE THAT BECOMES DUE.

FAILURE TO COMPLY WITH THESE CONDITIONS WILL RESULT IN THE KEEPER DETAILS BEING REQUESTED FROM THE DVLA TO PURSUE PAYMENT OR ISSUE A PARKING CHARGE NOTICE BY POST. IF ACTION IS REQUIRED TO RECOVER THE CHARGE, A REASONABLE ADDITIONAL FEE WILL BE ADDED.

IF THE PARKING CHARGE NOTICE IS PAID WITHIN 14 DAYS OF THE DATE OF ISSUE THE PARKING CHARGE NOTICE WILL BE REDUCED TO £40.00

A PARKING CHARGE NOTICE MAYBE ISSUED TO THE SAME VEHICLE FOR EACH 24-HOUR PERIOD.

WHEN YOU ENTER, WAIT OR OTHERWISE REMAIN IN THE AREA YOU AGREE TO THE COLLECTION, PROCESSING AND STORAGE OF PERSONAL DATA FOR THE PURPOSE OF ENFORCEMENT; TO ENSURE YOU ARE COMPLYING WITH THE TERMS AND CONDITIONS AND TO ENFORCE THESE AS REQUIRED; AND FOR CAR PARK MANAGEMENT (FOR EXAMPLE REPORTING ON VEHICLE TURNOVER AND REPEAT VISITS). WE WILL PROCESS DATA OBTAINED IN ORDER TO FULFIL OUR CONTRACTUAL OBLIGATIONS. DATA MAY BE COLLECTED VIA AUTOMATIC NUMBER PLATE RECOGNITION CAMERAS AND/OR ATTENDANTS ON-SITE AND VIA PAYMENT MACHINES OR TERMINALS. THE DATA COLLECTED COMPRISES OF IMAGES OF VEHICLES USING THE CARPARK AND/OR VEHICLE REGISTRATION MARKS. YOUR PERSONAL DATA WILL BE TREATED AS STRICTLY CONFIDENTIAL, AND MAY BE SHARED WITH OUR DEBT RECOVERY AGENTS, LAW ENFORCEMENT AGENCIES, ANPR AND BACK OFFICE SYSTEM PROVIDERS.

- Students who wish to use the Cheltenham or Forest of Dean car parks during stated opening hours must register their vehicles **and** display a valid Pay & Display ticket at the appropriate daily rate or pay by phone session. Only one vehicle* can be registered per student.
 - Students who wish to use the Gloucester car parks during stated opening hours must display a valid Pay & Display ticket or valid pay by phone session.
 - If you change your vehicle permanently, you must advise change of details immediately.
 - If you are driving a temporary vehicle, you must register with Reception **each day** that you wish to park the vehicle on site.
 - Cars and Motorcycles are to park in designated spaces only.
 - Students may be required to move vehicles, even when parked legitimately, for urgent operational reasons.
 - The college car park can be used by the student for the length of their course and during legitimate study. The car park may not be used outside of these times.
 - Students are encouraged to find alternative means of transport where possible.
 - Students who do not follow the car park rules will be subject to disciplinary procedures.
