Key points

Our Access and Participation Plan underpins our strategy to support all our HE learners to access and succeed in higher education. Our course entry criteria and approach to HE in FE encourages those with lower grades, mature learners without traditional qualifications and those who may not consider a university experience as being 'for them'.

The college has a significant proportion of HE learners who are from underrepresented groups/disadvantaged backgrounds, but we aim to increase the number of learners who have been entitled to free school meals enrolling onto HE courses.

Whilst our continuation (retention) rates are good the following students are less likely to be retained; a) those eligible for free school meals, b) those from more deprived socio-economic backgrounds (using the Index of Multiple Deprivation measure¹), c) learners with a declared disability and d) young learners (under 21)

Whilst our achievement rates are good, they are slightly lower for; a) learners from more deprived socio-economic backgrounds (using the IMD measure) and b) mature learners (aged 21 or over at outset of their course)

- £7700 for full time foundation degrees and postgraduate teacher training
- £7400 for full time students
- £3850 for part time postgraduate teacher training students
- £3700 for part time students

Eligible learners can apply for:

Gloucestershire low-income household bursary

£500 non-repayable annual bursary where eligibility is a household income is below £25k

¹ The Index of Multiple Deprivation (IMD) datasets are small area measures of relative deprivation across each of the constituent nations of the United Kingdom. Areas are ranked from the most deprived area (rank 1) to the least deprived area.

Care leaver bursary

£1000 non-repayable annual bursary for care leavers (eligibility: care leavers)

The Student Opportunities Fund: Learners from disadvantaged and under-represented backgrounds can apply for support where they are experiencing additional hardship.

<u>Information for students</u>

Prospective and current students receive information on fees and financial support at open evenings, by email communications and from the student services team on each campus. All current HE students have information shared via the HE Learner Community Team site.

What we are aiming to achieve

Based on assessment of our performance, we have identified the following areas on which to focus our work.

- 1. Access: In terms of access to our HE provision we aim:
 - To increase the percentage of learners eligible for free school meals (FSM) enrolling on fulltime HE courses from 14% to 19% by 2029.
- 2. Continuation: The college has high retention (continuation) rates for all HE courses, however we aim:
 - To increase continuation rates of Free School Meal (FSM) learners by increasing rates from 75% to 88% by 2029.
 - To eliminate the continuation gap between the most and least deprived socio-economic groups from 12ppt to 0ppt by 2029.
 - To eliminate the continuation gap between those with a disability and those without from 29ppt to 0ppt by 2029.
 - To increase continuation rates of young learners from 79% to 92% by 2029.
- 3. Completion: The college has high completion (achievement) rates for all HE courses, however we aim:
 - To eliminate the completion gap between the most and least deprived socio-economic groups learners by 2029 from 3.7ppt to 0ppt.
 - To eliminate the completion gap between mature and young FT learners by 2029 from 6.8ppt to 0ppt

What we are doing to address keys risks to equality of opportunity

ACCESS: What we do/plan to do to encourage applications from underrepresented groups.

The college continues to develop a range of activities that specifically target those from traditionally low participation areas and those who are eligible for free school meals, particularly by working to encourage internal progression from our further education learners.

This will be achieved through working in partnership with targeted schools, through our Uniconnect ² collaboration, provision of targeted 'why HE' tutorials with our FE cohorts, financial support, parent/carer engagement and HE taster events.

CONTINUATION AND COMPLETION: This will be achieved through:

- financial support/interventions
- increased pastoral support
- enhanced study support.
- individualised support plans
- · signposting to mental wellbeing support
- access to specialised support
- access to 'tech-ability'.
